TOURNAMENT RULES:

1. THIS TOURNAMENT IS CERTIFIED BY THE USBC.
2. OPEN ONLY TO MEMBERS OF THE USBC WHO ARE CERTIFIED THROUGH THE PORTAGE COUNTY USBC BA. USBC MEMBERS WHO ARE NOT CERTIFIED THROUGH PORTAGE COUNTY USBC BA MAY FILL OUT A LOCAL CERTIFICATION CARD THE DAY OF THE TOURNAMENT AND PAY ANY LOCAL DUES. WOMEN WHO ARE CERTIFIED THROUGH THE PORTAGE COUNTY USBC WBA, MUST CERTIFY THROUGH PORTAGE COUNTY USBC BA AS WELL.
3. TO DETERMINE YOUR AVERAGE, USE YOUR HIGHEST CERTIFIED AVERAGE (OF 21 OR MORE GAMES) FROM LAST SEASON. IF YOU HAVE NO CERTIFIED AVERAGE FROM LAST SEASON, USE YOUR HIGHEST CERTIFIED AVERAGE (OF 21 OR MORE GAMES) FROM THIS SEASON THE DAY OF THE TOURNAMENT (BRING PROOF). **THE 10 PIN (319a2) RULE IS WAIVED FOR THIS TOURNAMENT.** BOWLERS WITH NO QUALIFYING AVERAGE USE 220.
4. BOWLERS ARE RESPONSIBLE FOR VERIFYING THEIR OWN AVERAGES, WHETHER SUBMITTED BY THE BOWLER OR OTHERS (SEE USBC RULE 319a-3).
5. BOWLERS MUST REPORT PREVIOUS TOURNAMENT PRIZE WINNINGS AS A CONDITION FOR ENTRY ACCORDING TO USBC RULE 319d. FAILURE TO COMPLY WITH THESE PROVISIONS IS CAUSE FOR A FORFEITURE OF ENTRY FEE AND PRIZE WINNINGS.
6. ALSO USBC RULE 319e ABOUT REPORTING TOURNAMENT AVERAGE OVER THE LAST 12 MONTHS APPLIES TO THIS TOURNAMENT. FAILURE TO USE THE ADJUSTED AVERAGE IN ACCORDANCE WITH THE FOREGOING IS CAUSE FOR FORFEITURE OF ENTRY FEE AND PRIZE WINNINGS.
7. TO DETERMINE HANDICAP USE 90% OF THE DIFFERENCE BETWEEN BOWLER'S AVERAGE AND 220. BOWLERS WITH NO QUALIFYING AVERAGE MUST USE A 220 AVERAGE AND ZERO HANDICAP. BOWLERS WITH AVERAGES HIGHER THAN 220 USE ZERO HANDICAPS.
8. ENTRY FEE IS \$60.00 PER TEAM PRIOR TO THE DAY OF THE TOURNAMENT, OF WHICH \$41 GOES INTO THE PRIZE FUND. ENTRIES RECEIVED THE DAY OF THE TOURNAMENT WILL BE CHARGED A \$10.00 FEE. THIS MONEY WILL BE APPLIED TO THE PRIZE FUND OF THE TOURNAMENT.
9. NO PBA MEMBERS WILL BE ALLOWED TO BOWL UNLESS THEY HAVE BOWLED 21 OR MORE GAMES IN A CERTIFIED LEAGUE IN PORTAGE COUNTY THIS SEASON.
10. DISPUTES AND APPEALS MUST BE SUBMITTED TO THE TOURNAMENT DIRECTOR IN WRITING BEFORE PRIZE MONEY IS PAID (SEE USBC RULE 329).
11. THE QUALIFYING ROUND WILL BE ONE SQUAD OF 4 GAMES ACROSS 8 LANES. FROM QUALIFYING: AT LEAST 1 IN 5 TEAMS WILL CASH. **FOUR TEAMS WILL ADVANCE TO THE FINALS.** A TIE FOR THE FINAL QUALIFYING SPOT WILL BE BROKEN] WITH A 9TH AND 10TH FRAME ROLL-OFF.
12. THE FINALS: WILL BE TWO GAMES. FINAL PLACES WILL BE DETERMINED BY THE TOTAL OF THE TWO GAMES IN THE FINALS ONLY. A TIE FOR FIRST PLACE WILL BE BROKEN] WITH A 9TH AND 10TH FRAME ROLL-OFF.
13. NO CHECKS WILL BE ACCEPTED WITHIN FOUR DAYS OF THE TOURNAMENT.
14. ONLY ENTRIES PAID IN FULL WILL GUARANTEE A SPOT IN THE TOURNAMENT.
15. ALL BAD CHECKS WILL BE CHARGED FOR AT LEAST THE AMOUNT OF CHECK PLUS BANK FEES. IF NOT PAID, LEGAL ACTION AND USBC DISQUALIFICATION WILL BE PURSUED.
16. ENTRIES CLOSE 30 MINUTES PRIOR TO THE START OF THE TOURNAMENT.
17. ENTRIES ARE LIMITED TO 48 TEAMS UNLESS MORE LANES ARE AVAILABLE.
18. 100%.OF THE PRIZE MONEY COLLECTED WILL BE RETURNED IN PRIZES.
